Dear Muhaned:

This letter is to notify you that administrative modification amendment #19 to Shasta County's 2008 FTIP, with current CTIPS projects versions, was electronically transmitted to Jody Tian today.

The administrative modification adjusts the Highway Bridge Project (HBP) Grouped Project (211-0000-0083) to match the October 30, 2009, update. The HBP funding was increased \$225,000 in 09/10 and \$1,644,000 in 10/11. The related local match was increased \$216,000 in 10/11. Project 211-0000-0084, Bridge Preventative Maintenance Program (Planning...), was deleted. The funding was moved to the group HBP to match the October 30, 2009, HBP update. Project 211-0000-0069, Twin View Bridge Replacement, was decreased by \$100,000 in 09/10 to match the October 30, 2009, HBP update.

The projects in this request are not part of any outstanding formal amendment provided to your department.
